### Invitation for Bids for the CONSTRUCTION OF DEEP TUBEWELL AND ROAD

1. **Ratnanagar Municipality, Chitwan** invites electronic bids from Nepalese eligible bidders for the construction of **Deep tubewell and Road under** National Competitive Bidding procedure.

Bidders, should deposit **non-refundable fee of Nrs. 3000 for each package** of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Electronic bids must be submitted to the office **Ratnanagar Municipality, Bakulahaar, Chitwan** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12 pm** on **7<sup>th</sup> May, 2019**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1 pm on 7<sup>th</sup> May, 2019** at the office of **Ratnanagar Municipality, Bakulahaar, Chitwan**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in, amounting to a minimum of **following amount, for each package** given below, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
