4. Sealed bids must be submitted to the office of Ratnanagar Municipal Executive by hand on or before 12:00 on **21<sup>st</sup> April, 2019**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **1 pm on 21<sup>st</sup> April, 2019** at the office of **Ratnanagar Municipality, Bakulahaar, Chitwan**. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security amounting to a minimum of **respective value for each package shown below** which shall be valid for 30 days beyond the validity period of the bid. If bidders wish to submit the cash security, the cash should be deposited in Deposit Account No: **1310303007103 at Rastriya Banijya Bank, Bharatpur, Chitwan** and submit the receipt of the deposited amount of cash along with Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
