




Invitation for Bids Ratnanagar Municipality Office Ratnanagar, Chitwan Invitation for Bids

1. Ratnanagar Municipality office, Ratnanagar Chitwan invites sealed bids or Electronic bids from eligible bidders under National Competitive Bidding procedures. Bidding is open all eligible Nepalese bidders.
2. A complete set of Bidding Documents may be purchased at office hours from the Ratnanagar Municipality office, Ratnanagar, Chitwan by eligible Bidders on submission of written application, along with duly attested copies of Firm registration, VAT registration, and tax clearance certificate (Valid for fiscal year 2073-74), Joint venture agreement (in case of JV) and upon the payment of a non-refundable fee as mentioned in the table below within the office hour on or before 2075/03/24.
3. Information to pay the cost of bidding document : **Name of Office: Ratnanagar Municipality, Ratnanagar, Chitwan**
4. Information to deposit the cost of bidding document and Bid security Amount in Bank: **Name of Office: Ratnanagar Municipality, Ratnanagar, Chitwan, Name of Bank: Rastriya Banijya Bank, Bharatpur, Account no:1310303007103**
5. The purchased bid document shall be submitted within deadline by sealed envelope addressing to the mentioned above office, indicating contract identification number, name of the bidder's firm and its detail address.
The bid must be submitted at Ratnanagar Municipality Office on or Before 12:00 hours on 2075/03/25.
6. Bids shall be opened in the presence of Bidder's representatives who choose to attend at 14:00 hour on 2075/03/25 at Ratnanagar Municipality Office, Ratnanagar, Chitwan. Nonattendance of any or the Bidder's entire representative doesn't care for the opening of Bid.
7. Bids must be accompanied by a bid security of minimum amount specified in table below either in the form of bank Voucher conforming cash deposit in deposit account specified above or a bid security (unconditional bank guarantee) issued by "A" class commercial Bank as approved by Nepal Rastra Bank . The Bid must be valid for a period of **90 days (Ninety days)** after bid opening and Bid security must be valid 30 days beyond the bid validity period. Bidder must clearly quote the contract name and contract number in bid security form (Bank Guarantee) otherwise will cause disqualification of Bidder. Bidder who choose to submit their bids electronically shall submit the scan copy of bid security amount deposit slip or Bank guarantee.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Ratnanagar Municipality office reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
10. Bidders are advised to visit the site and assess the actual site condition before submitting the bids at their own cost.
11. The bidders who submit the bid electronically are requested to submit all the original hardcopy document including bid document within 7 days after bid submission date at Ratnanagar Municipality Office, Ratnanagar, Chitwan.
