The Government of Nepal (GoN) has allocated funds towards the cost of **Budi Kulo- Sital Chwok- Tandri Chwok Road** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Side Drain and Footpath of Budi Kulo- Sital Chwok-Tandri Chwok Road, IFB No.: Rat/Chitwan/NCB/Works/01/2075-76**. Bidding is open to all eligible Nepalese Bidders.
2. **Office of Ratnanagar Municipality** invites sealed bids from eligible bidders for the construction of **Side Drain and Footpath of Budi Kulo- Sital Chwok- Tandri Chwok Road** under National Competitive Bidding procedures.

4. A complete set of Bidding Documents may be purchased from the office of **Ratnanagar Municipality, Chitwan** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs. 3000/-** till **2075/06/21**.
5. Pre-bid meeting shall not be held.
6. Sealed bids must be submitted to the office of **Ratnanagar Municipality, Chitwan** on or before **12:00 noon** on **2075/06/21**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 2075/06/21** at the office of **Ratnanagar Municipality, Chitwan**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of **NRs. 2,08,500/-** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
